

GOVERNMENT OF PAKISTAN ISLAMABAD HEALTHCARE REGULATORY AUTHORITY (IHRA)



INTRODUCTION

The population of Islamabad is growing at a very rapid pace as compared to other Districts of Pakistan, mainly as a result of In-migration. With current population of approx. 2.3 million, about 1.2 million living in rural areas of Islamabad, where health facilities and quality of healthcare services have not been improved over the past few decades resulting in increased quackery, poor referral system and dissatisfaction among people regarding provision of poor quality of services. Moreover, with the current growth rate, the urban population of Islamabad is expected to exceed 2.2 million by 2030, which will escalate healthcare service demand and will further increase the burden of healthcare service on tertiary hospitals for providing healthcare services not only for the people of Islamabad but also for the people referred from Punjab, KPK, AJK, and Gilgit Baltistan etc. Keeping this in view, Islamabad Capital should have state of the art model healthcare system, which should provide healthcare services not only in peace time but also during emergencies.

As per data of the Ministry of National Health Services, Regulation & Coordination, there are 1488 health facilities (119 public and 1369 private) in rural and urban areas of Islamabad. There are 64 hospitals including three public sector tertiary care hospitals (Pakistan Institute of Medical Sciences (PIMS), Polyclinic Hospital and CDA Hospital), 48 dispensaries and 75 medical centres. Moreover, a number of maternal & child centers, family welfare centers, private clinics, maternity and nursing homes, homeopathic and hakeems are functional in rural and urban areas of Islamabad. In addition, a total of 302 Lady Health Workers at the community level with a population coverage ratio better than that of the national level.

Segregation of healthcare to different departments and lack of clear roles and responsibilities of district health office, CDA health services, and Chief Commissioner Office is a challenge, which led to poor regulations, lack of coordination, quackery, poor referral, inequality in provision of healthcare services, and dissatisfaction among people and healthcare providers. Although exact data related to quacks is not available but it is estimated that there is an increased number of private clinics, medical stores and laboratories run by un-qualified personals. Such unsafe practices have resulted into increased quackery. Moreover, lack of knowledge about preventive diseases such as malaria, tuberculosis, hepatitis, childhood infection, HIV/AIDS, and poor health and nutrition practices such as unsafe injections, increased use of low-quality medicines including antibiotics has resulted in high prevalence of communicable and non-communicable diseases in Islamabad. Lack of trained health human resource is another challenge which leads to poor health system delivery in Islamabad.

ISLAMABAD HEALTHCARE REGULATORY AUTHORITY (IHRA)

In order to regulate healthcare establishments and to ensure effective coordination, Islamabad Healthcare Regulatory Authority (IHRA), an autonomous health regulatory body was enacted under the Islamabad Health Regulation Act, 2018. IHRA aims to improve the quality, efficiency and safety of healthcare services delivery by adopting evidence-based regulatory standards for registration and licensing of healthcare establishments, health professionals & equipment, and developing and enforcing minimum standards of safety for patients, healthcare professionals and other staff in healthcare establishments (both in public and private) in the Islamabad Capital Territory.

IHRA has undergone significant changes in recent times by expanding staff numbers and capacity of the organisation to develop policies, strategies, SOPs, and minimum service delivery standards (MSDSs). Healthcare establishments under IHR Act 2018 are required to get registered with IHRA and implement minimum services delivery standards to acquire license to render health services in the Islamabad Capital Territory.

IHRA Vision –	"Safe and High-Quality Healthcare Services for everyone in the Islamabad Capital Territory."
IHRA Mission –	"Regulate the provision of healthcare in ICT to ensure high efficiency, safety and effectiveness in delivering health services both in public & private sector."

Strategic Goals – IHRA vision and mission is achieved through the following four Strategic Goals:

- 1. **<u>Regulated and Accountable Healthcare Sector</u>**: By ensuring that all healthcare facilities, professionals, and equipment are registered in the ICT and meet the required minimum service delivery standards as well as licensing standards.
- 2. <u>Safe and Trusted Health Services:</u> Through continuous assessment of the quality of health services provided to ensure compliance with IHRA standards and ensure the safety of medicine and medical equipment used in the healthcare establishment and safety of clinical research conducted in the ICT.
- 3. <u>Protected Health Rights:</u> by Preserving patients' rights and safety, IHRA will act to protect the rights and the safety of all people using the healthcare facilities.
- 4. <u>Improved Internal Capabilities:</u> By ensuring strong internal systems, resources and expertise to meet the challenges of the ever-changing regulatory environment.

FUNCTIONS OF IHRA

As per the Islamabad Health Regulation Act, 2018, IHRA is responsible for maintaining a register of all healthcare establishments, setting standards for registration and licensing of healthcare establishments. In addition, its functions include but not limited to the following:

- Registration, licensing and regulation of healthcare establishments, healthcare professionals and equipment
- Enforce minimum standards of safety for patient, healthcare professional and other staff in a healthcare establishment
- Regulate healthcare establishments in accordance with standards and notified practices
- Development of code of conduct for professionals to meet quality assurance/minimum service delivery standards
- Issue standing orders to ensure provision of quality healthcare services by healthcare establishments
- Grant, renewal, suspension, cancellation or revocation of registrations of healthcare establishments, its healthcare professional and equipment
- Monitor and regulate healthcare services quality levels and standards
- Constitute committees i.e. inspection committee, complaints committee, review committee etc.
- Investigate complaints relating to healthcare establishments, healthcare professional, healthcare services and/or medical negligence
- Organize and arrange various educative programs, seminars, conferences and meetings
- Take steps for coordination with healthcare establishments, for implementation of various health improvement, disease prevention, curative, rehabilitative and palliative programs
- Collaborate with international and national institutions, organizations and companies to secure their assistance, cooperation and support for improvement of healthcare establishments for provision of quality healthcare services

KEY ACTIVITIES CARRIED OUT DURING 2020-21

Following are the department-wise activities carried out during the reporting period:

1. Registration & Licensing


Under Section 21 & 22 of the Islamabad Healthcare Regulation Act 2018, it is mandatory for all healthcare service providers to apply for registration and licensing of their respective healthcare establishments. As per Section 14 (1) of Islamabad Healthcare Regulations Act, 2018.

"No healthcare establishment shall render any healthcare service unless it is registered with the registration board under this act subject to the terms & conditions as a registration board may determine on case-to-case basis at the time of registration and no healthcare establishment shall render any healthcare services for which it is not licensed". Accordingly, Healthcare establishments are required to get registered with IHRA and implement quality healthcare service standards to acquire license to render health services in the Islamabad Capital Territory.

Public notice for registration and licensing of healthcare establishments of ICT was published in the leading national newspapers. Accordingly, a total of 580 applications were received, out of which, 100% were responded through official correspondence. Letters were sent to 240 HCEs for submission of missing documents required for issuance of provisional registration. Out of the total applications received, 340 HCEs were provisionally registered with IHRA. List of provisionally registered healthcare establishments is attached as **Annex-A**.

2. Inspection

The Inspection Department has made a significant contribution in improving the quality of healthcare services in Islamabad Capital Territory by carrying out pre-assessment of the healthcare establishments which were to be licensed, where IHRA inspection team assisted HCEs staff in identifying and eliminating gaps in the implementation of Quality Healthcare Service Standards (QHSS). A total of 133 visits were carried out to 110 HCEs including Adult Vaccination Centers for COVID-19.



3. Complaint Management


The Authority is empowered under section 33 of Islamabad Healthcare Regulations Act, 2018 to investigate the complaints relating to healthcare establishment, healthcare professional, healthcare services and medical negligence. In this regard, a complete Complaint mechanism has been devised and complaint Regulations have been drafted, approved and implemented. The Authority is dealing with two (2) types of complaints i.e. Citizen Portal Complaints and Written Complaints supported by an affidavit. Details are as under:



4. Clinical Governance

The IHRA Directorate of Clinical Governance is responsible for developing Quality Healthcare Service Standards for all types of Healthcare Establishments (HCEs). This includes hospitals, teaching hospitals, surgical centers, maternity homes, nursing homes, clinics, dispensaries, dentistry, dental clinics, clinical laboratories, x-ray laboratories, diagnostic centers, ambulatories, cosmetic centers, psychiatric hospitals, burn units. psychiatric nursing home, community mental health center, hemodialysis center, dialysis centre, patient rehabilitation center, slimming clinic or centre, hair transplant clinic, domiciliary care, home based services and such other healthcare or health-related premises as the Federal Government may, by notification in the official Gazette, specify. The level of standards ranges from minimum to that of accreditation, keeping in view the local context and the ground realities.

The Directorate is also responsible for developing the related rules, regulations and reference materials covering guidelines to facilitate successful implementation of these standards by the HCEs. In addition, the guidance material and tools to facilitate the IHRA Inspection Teams for assessment of implementation level and to facilitate decision making at IHRA for issuance of license and/or provide advice to the HCEs to improve in case of non-compliance and low scoring.


With the absence of designated Director, Deputy Director Inspection is looking after the Clinical Governance Directorate. To respond to the capacity needs of the stakeholders, the IHRA management has adopted a facilitative role, and is planning to conduct orientation and training for HCEs on IHRA quality healthcare service standards.

The Directorate has developed the following six (06) quality healthcare service standards (QHSS) to cover all aspects of healthcare service delivery including clinical and managerial areas.


- i. Standards for Hospitals
- ii. Standards for Primary Healthcare Facilities
- iii. Standards for Dental Clinics
- iv. Standards for Clinical Labs
- v. Standards for Tib
- vi. Standards for Rehabilitation Centers

5. Coordination

Islamabad Healthcare Regulatory Authority (IHRA) has a large number of employees, departments / sections performing different functions. All these functions are important to achieve the overall goal of improving the quality of healthcare services for the people of Islamabad Capital Territory. However, if employees, departments or sections work in isolation, then they might not be able to effectively achieve the common goal. Therefore, coordination is essential not only to integrate the efforts, skills, activities and functions of IHRA but also to eliminate duplication of work leading to cost-efficient operations. Coordination at IHRA involves a collaborative effort to implement IHR Act 2018, laws, protocols, quality healthcare service standards and communication and collaboration to achieve the overall goal of IHRA. Coordination Unit mainly deals with internal and external coordination based on the instructions of the Authority.



The Unit reinforces the capacity of IHRA team by providing an overall coordination work in close collaboration with IHRA team, Government Ministries and line departments, thematic groups and committees, technical advisors and experts, development partners, multi-lateral and bi-lateral donors and civil society.



Major Achievements of Coordination Unit

- Active coordination and networking with M/o NHSR&C, M/o Narcotics Control, NCOC, DHO, Chief Commissioner's Office, Healthcare Commissions, PMC, WHO, UNODC, UNICEF, etc.
- Developed IHRA Strategy 2021-24
- Coordinated and organized meeting with UNODC for technical support and prepared Minutes of the Meeting.
- Managed Facebook & Twitter pages, and WhatsApp group of IHRA for sharing of information internally within IHRA team and externally to the public.
- Prepared content for IHRA Website.
- Developed briefing material (brief / talking points) for CEO IHRA, letters, notifications, and regular correspondence with the M/o NHSR&C.

- Provided technical inputs and comments on the Draft bill to provide framework and mechanism in relation to drug prevention, treatment and rehabilitation.
- Coordinated with Provincial Healthcare Commissions (Punjab, Sindh and KPK) for nominations of staff to participate in trainings on DDR regulatory framework Quality Assurance (QA).
- Developed SOPs for File Management & Tracking.
- Represented IHRA in four Technical Committee Meetings on Quality Assurance (QA) of Drug Regulatory Framework for Treatment & Rehabilitation of Drug Dependents.
- Prepared and updated IHRA progress for 3rd and 4th quarter on Prime Minister's Performance Agreement Portal
- Represented IHRA in Technical Committee Meetings on Corona for ICT.
- Coordinated with Punjab Healthcare Commission for technical support regarding MSDSs, capacity building training, and knowledge sharing/exposure visit of IHRA staff to PHC.

6. Monitoring & Evaluation

On very initial stage of planning, targets setting and annual work planning of IHRA, M&E team adopted collaborative approach to monitor the implementation process of activities. M&E team opted monitoring techniques of result-based monitoring and process monitoring by regularly liaising with all departments to acquire updated plan(s) and adjusted the frequency of monitoring activities accordingly. For result-based monitoring monthly, annually and organizational targets were assessed against performance and in process monitoring SOPs defined in IHRA ACT 2018 along with regulations were monitored to assess the implementation of set standards. For each department separate set of monitoring tools were prepared and approval was sought from the CEO. Each monitoring and evaluation tool was pilot tested before initiation of monitoring activities. The idea to use mobile application for monitoring team was also envisioned in future plans of IHRA.

M&E team segregated the internal and external components for monitoring purposes. Internally, standard operating procedures were followed to assess the performance against indicators. External component includes onsite visits to the HCEs and quacks, during these visits predefined and approved tools were used to assess the quality of inspection/assessment conducted by IHRA staff as well as the level of quality standards followed by HCEs in compliance of MSDS.

As priority areas, registration, licensing, assessments and inspection activities were monitored by using systematic approach so that all inspection officers get equal chance to be monitored during field activities. Registration process, monitored to assess the timeliness of process i.e. the duration mentioned in the act for provisional and confirmed licenses are followed by the registration staff. Secondly, timely submission of cases to registration committee and occurrence of committee as per meeting calendar were monitored and detailed report was submitted to Director Registration and Licensing for informed decision making. Initial assessments and regular inspection visits monitored by visiting the HCEs during the assessment/inspection process and verification process was carried out after completion of assessment/inspection process. This process monitored and verified the timeliness, accuracy of data collection, compliance of approved checklist and overall transparency of assessment/inspection process.

Complaint response mechanisms both at IHRA and HCEs were monitored to ensure that complaints are properly registered along with defined solution process and all documentary proofs are available and kept properly. Monitoring of qualified HCEs for compliance of MSDS was carried out on regular basis, number and frequency of monitoring visits were adjusted as number of registered HCEs increased.

Quacks who have been identified are listed at IHRA and recommended process initiated against them and tracking of progress was in placed and surprise visits conducted to ensure that they are not operational again or they have taken corrective measures recommended by the IHRA. Hearings of IHRA tribunals were monitored to ensure that approved checklist is used during the hearing process and timeliness followed as per Act. Capacity building trainings of staff along with training of HCEs professionals on MSDS 100% monitored.
