NOTIFICATION

Islamabad, the January, 2025

S.R.O (1)/2025.- The following draft of the Islamabad Healthcare (amendment) Regulations, 2025 which are proposed to be made by the Islamabad Healthcare Regulatory Authority, with previous sanction of the Federal Government, in exercise of the power conferred by section 47 of the Islamabad Healthcare Regulation Act, 2018 (XXIII of 2018) are hereby published, as required by sub-section (2) of the said section 47, for the information of the all persons likely to be affected thereby and notice is hereby given that the said draft shall be taken into consideration after fifteen days of its publication in the official gazette. Any objections or suggestions which may be received from any person, with respect to the said draft before the expiry of the aforesaid period, shall be taken into consideration by the Islamabad Healthcare Regulatory Authority, with previous sanction of the Federal Government.

Draft Islamabad Healthcare (Amendment) Regulations, 2025

WHEREAS, the Islamabad Healthcare Regulatory Authority (IHRA) is revising its fee structure for the registration and licensing of healthcare establishments and practitioners;

AND WHEREAS, the objective of this revision is to establish a fair, transparent, and supportive fee system that accommodates the diverse needs of healthcare providers, ensuring accessibility, sustainability, and continued compliance with regulatory standards for quality healthcare.

It is hereby enacted as follows:

1. Short title and commencement. - (1) These regulations shall be called the Islamabad Healthcare (Amendment) Regulations, 2025.

(2) These regulations shall come into force at once.

2. Amendment of Regulation 66 of the Islamabad Healthcare Regulations, 2023.- In the Islamabad Healthcare Regulations, 2023 (S.R.O. 07(I)/2024, the schedule III as mentioned in Regulation 66 in sub-section (1), shall stand omitted and substituted with new Schedule III attached herewith.

3. Amendment of Regulation 69 of the Islamabad Healthcare Regulations, 2023.- In the Islamabad Healthcare Regulations, 2023 (S.R.O. 07(I)/2024, in Regulation 69 in sub-section (1), the expression “Schedule V” stand omitted and the expression “Schedule III” shall be substituted thereof.

- b) The fees may be increased @ ten percent after every two years.
